Sub: Clarification on documents to be submitted by the applicants applying for Indian Citizenship under Section 6B of the Citizenship Act, 1955 as mandated under Schedule IA of the Citizenship (Amendment) Rules, 2024, (CAR-2024).



Please refer to Board's letter of even number dt. 09.04.2024. vide which all Zonal Railways were advised to take appropriate action in regard to finalization of nomination of invitee members for the State as well as District level Empowered Committee and to furnish the nomination details to concerned Director (Census Operation) of the States/UTs, so that the process for grant of Indian Citizenship to the persons covered under the Citizenship (Amendment) Act, 2019 may be operationalized. In this regard, a copy of letter dt. 08.07.2024 received from Director (Citizenship), Citizenship Wing, Foreigners Division, M/o Home Affairs on the subject mentioned above is enclosed.

2. As stipulated in the enclosed letter, M/o Home Affairs, on receiving numerous queries requesting to clarify as to what type of documents may be accepted from the applicants against Sr. No. 8 of the Schedule-IA of the Citizenship (Amendment) Rules, 2024, have clarified that the documents under Sr. No. 8 of the Schedule-IA may include any document issued by the Central Government/State Government/any Judicial or Quasi Judicial body in India such as land record, Judicial order etc., identifying or representing that the applicant or their parents or grandparents or great grandparents had been a national of Afghanistan or Bangladesh or Pakistan.

3. In this connection, all concerned Zonal Railways are advised that the concerned DRMs may please be instructed to disseminate the above clarification as given by M/o Home Affairs to respective representative of jurisdictional DRMs nominated for State Level Empowered Committee and further they may be advised to pass it on to the concerned Station Masters for District Level Committee, constituted for processing of grant of citizenship applications under Citizenship (Amendment) Act, 2019.

Sub : Clarification on documents to be submitted by the applicants applying for Indian citizenship under Section 6B of the Citizenship Act, 1955 as mandated under Schedule IA of the Citizenship (Amendment) Rules, 2024, (CAR-2024).

Sir/Madam,

Please refer to this Ministry's communication of even number dated 12th March, 2024 (Annexure - I). The Citizenship (Amendment) Act, 2019 was notified on 12th December, 2019 and came into force w.e.f. 10th January, 2020. Ministry of Home Affairs vide Notification GSR No. 172(E) dated 11th March, 2024 has notified the Citizenship (Amendment) Rules, 2024 inter-alia providing provisions for grant of Indian citizenship to the persons who are eligible under the Citizenship (Amendment) Act, 2019.

2. The Ministry of Home Affairs vide Statutory Order No. 1241(E) dated 11th March, 2024 has issued order specifying the authority(s) who are required to process /decide the citizenship application preferred by eligible persons in pursuance of the Citizenship (Amendment) Rules, 2024 read with the Citizenship (Amendment) Act, 2019. The Designated Officer (D.O.) of the District Level Committee (DLC) have started scrutinization of citizenship applications and are forwarding the applications to the State Level Empowered Committee (SLC) for decision. The respective Director (Census Operations) (DCO) have also started granting Citizenship Certificate (C.C.) to the eligible applicants.

3. It may be observed that in Schedule - IA of the Citizenship (Amendment) Rules, 2024 i.e. the list of documents to prove that the applicant is a national of Afghanistan or Bangladesh or Pakistan (Annexure - II), at Sr. No. 8 the following is admissible : -

"Any documents that shows that either of the parents or grandparents or great grandparents of the applicant is or had been a citizen of one of the three countries i.e. of Afghanistan or Bangladesh or Pakistan."

4. The Ministry has been receiving numerous queries requesting to clarify as to what type of documents may be accepted from the applicants against Sr. No. 8 of the Schedule - IA of the Citizenship Rules, 2024.

5. In this regard, it may be clarified that the documents under Sr. No. 8 of the Schedule - IA may include any document issued by the Central Government/State Government/any Judicial or Quasi Judicial body in India such as land record, judicial order etc., identifying or representing that the applicant or their parents or grandparents or great grandparents had been a national of Afghanistan or Bangladesh or Pakistan.

6. The above clarification may taken note of while deciding any citizenship application under Citizenship (Amendment) Act, 2019 (CAA).

7. This issues with the approval of the Competent Authority.
