1600	All traffic facilities other than those covered under Plan Head 5300	All traffic facilities other than those covered under Plan Head 5300. If a New Goods Shed including track work is developed, whole work shall be charged to PH-16.
5300	Customer Amenities - passenger/other amenities and Development & up gradation of freight terminals including circulating area for movement of road vehicles, approach roads, illumination for night working, parking space for trucks, platforms, covering of platforms, infrastructure for handling of crane consignments/loose commodities, drainage in go down area, storage facilities/warehousing, office and waiting halls, facilities for labour but excluding track related works (viz., works like providing of full rake length capacity spurs, direct entry/dispatch of rakes)	Customer Amenities -passenger/other Railway user amenities and up gradation of freight terminals including circulating area for movement of road vehicles, approach roads, illumination for night working, parking space for trucks, platforms, covering of platforms, infrastructure for handling of crane consignments/loose commodities, drainage in go down area, storage facilities/ warehousing, office and waiting halls, facilities for labour . Work (s) related to up gradation/creation of facilities at existing Goods shed including track works, shall be charged under PH-53 i.e customer amenities.
