Approval of the competent authority is hereby communicated for inter Railway Request transfer of Shri Heeralal Meen, Trackman, SSE/P.way/HPT BL in Pay Band Rs. 5200-20200 with Grade Pay Rs. 1800 to Jaipur division of Northwestern Railway on bottom seniority in the recruitment grade of Trackman, Accordingly he is transferred to Jaipur division of North western Railway Subject to the following conditions:-

- a) As the transfer is ordered at his own request, he is not entitles for any benefit on transfer account
- b) His lien and seniority will be maintained in his parent seniority unit until he is permanently absorbed in the new seniority unit to which he is posted
- c) He will rank junior most to all permanent/temporary trackmen on the date he joins the new seniority unit in jaipur division of NWR
- d) He should be from DAR/SPE/VIG cases as on date of his relief
- e) No due should be pending against him before relief relieving.
- f) He should vacate Railway Quarters if in occupation or seek for retention as permissible under rule and also handover all railway property, if any in his possession to his immediate supervisor before being relieved.
- g) Before relieving the employee concerned, an under taking may be obtained for acceptance of all the conditions mentioned above and the following formalities may be complied with in terms of Railway boards ltr No E (NG) - 2001/TR/16 dtd 21.11.2001
- h) The release memorandum should have the signature and photograph of the employee pasted on it duly attested in a manner that the signature of the releasing officer and the rubber stamp below that appear partially on the photograph and partially on the paper outside photograph.
- i) Sparing memo should have the signature of the transferred employee and his/her thumb impression both of which should be duly attested by the officer signing the releasing memorandum/order with officers name and designation appearing below the signature. oncerned..
