Sub:- Financial up gradation under Modified ACP SCHEME 2008 -Electrical Department..

Ref:- Railway Bd's letter No. PC/V/2009/ACP/2 dtd. 10.6.2009 (RBE/No. 101/2009)

In terms of provisions contained in RBE No.101/2009, the eligibility for financial up gradation to the next higher Grade Pay in the hierarchy of recommended revised Pay Bands and Grade Pays as given in Section 1, Part A of the first schedule of Railway Services (Revised Pay) Rules,2008 (RBE No.103/2008) have been examined by the Screening committee and have been found the following employees eligible for grant of non-functional up gradation under MACP scheme with effect from the date indicated against each in the following categories of Electrical department /Hubli division and Pay fixed on MACP as under .



The above financial up gradation is granted, subject to the following conditions:

1. There are no DAR/SPE/Vig Cases pending against them as on the date of effecting the financial up gradation .
2. The above employees are eligible for exercising pay fixation option under rule 1313(I)(a)(i) of R-II with in a period of one month from the date of issue of this order subject to the following conditions:
 - (i) In future, regular promotion happens to be in a post carrying same grade pay as what is granted under MACPS, NO PAY FIXATION will be allowed on regular promotion.
 - (ii) IN future, if regular promotion happens to be in post carrying higher grade pay than what is granted under MACPS, no pay fixation will be allowed but only difference of grade pay will be granted on regular promotion.

3. The MACPS contemplates merely placement on personal basis in the immediate higher grade pay/grant of financial benefits only and shall not amount to actual/functional promotion of the employee concerned. There will be no change in the designation or promotion of the employee concerned. There will be no change in the designation or the nature of duties performed by the employee, i.e. the status of the employee will remain unchanged during the financial up gradation period.

4. Financial up gradation under MACPS shall be purely personal to the employee and shall have no relevance to his seniority position. As such, there shall be no additional financial up gradation/stepping up of pay for the senior employees on the grounds that the junior employee in the grade has got higher Pay/Grade Pay under MACPS.
