




They should vacate the Railway quarters, if in occupation, before carrying out the transfer orders.



The above promotions are ordered subject to the following conditions that:-

1. The promotions ordered above are provisional subject to the condition that the concerned employees are free from DAR/SPE/VIG. cases and not undergoing any penalty debaring them for such promotion which should be ensured by the Supervisor before implementing the orders.
2. Their Promotion is subject to disposal of cases, if-any, pending in Hon'ble High Court/ Supreme Court/CAT, etc. as the case may be.
3. They may exercise option for re-fixation of pay in the promoted grade within one month from the date of promotion in terms of Rule No. 1313 (FR-22)(i)(a)(i) from the date of accrual of next increment in terms of instructions contained in RBE No. 132/2008. Option once exercised will be final.

4. In terms of CPO/SWR's letter No.SWR/P./R/186 dt 28.02.2012, they will be on probation for a period of one year from the actual date of promotion and their confirmation in the post will be subject to successful completion of the probationary period to which promoted. If the appointing authority considers that their work has not been satisfactory during the probation period, they are liable for reversion to the post from which they were promoted or their probation can be extended.


5. The fixation of pay is done as per CPO/SWR/UBL's letter No. SWR/P/R/524 dated 12.10.2011 & 27.09.2012.

6. Sl. Nos. 20 to 60 except Sl. No. 25, 32 & 53 are eligible for all the benefits on transfer account. They should vacate the Railway Qrs. if in occupation before carrying out the promotional transfer.

7. If any of the employees are unwilling for promotion, the same should be obtained in writing by the concerned Supervisory official within 15 days from the date of issue of the order and it should be forwarded to this office immediately without fail.

8. The employees are eligible to draw higher rate of pay from the date they shoulder higher responsibilities.

9. The date of shouldering higher responsibility should be immediately advised to this office and all concerned without fail.
