The above promotion order is issued subject to the following conditions.

1. The above promotion is provisional and subject to the disposal of appeals/applications/cases pending in various Courts, CATs and also subject to the condition that he is free from any SPE/DAR/Vig.cases.
2. The promotion will take effect from the date of shouldering higher responsibility.
3. They should be free from DAR/SPE/Vig. cases as on date and not undergoing any penalty debarring them for such promotion.
4. They will be on probation for a period of one year from the actual date of promotion and their confirmation in the post will be subject to successful completion of the probationary period to which promoted. If the Appointing Authority considers that their work has not been satisfactory during the probation period, they are liable for reversion.

5. The above promotion should be implemented within 15 days from the date of issue of this order.
6. If the employees are unwilling for promotion, the same should be obtained in writing within 15 days from the date of issue of this order by the concerned supervisory officials and it should be forwarded to this office immediately without fail .
7. The date of shouldering the higher responsibility of the above mentioned employees to be advised to all concerned.
8. The postings are temporary and the employees are liable for transfer during periodical transfers according to new distributions/Pin-Pointing of posts.
9. The employees may exercise option for fixation of pay in the promoted grade within one month from the date of promotion under Rule 1313 (FR22)(1) (a) (i) on the date of accrual of next increment in the lower post in terms of Railway Board's letter No.E(P&A) II-81 PP-4 dated 13.11.81 & RBE No. 132/2008 dated 25.09.08. Option once exercised shall be treated as final.
