Sub: Promotion to the post of Mail/Express Guard
in PB Rs.9300-34800 +GP 4200 in Operating Department

Ref:- This office select list of even No.dtd.22.10.14.

Sri.Mahendra M Binnal (ST), Senior Passenger Guard/UBL (PF No.07267642, SR No.G-186) working in PB Rs.9300-34800+GP-4200 who is placed on the select list for promotion to the post of Mail/Express Guard in PB Rs. 9300-34800 +GP-4200 vide reference cited above is now promoted as Mail/Express Guard in Functional Grade in PB Rs. 9300-34800 +GP-4200 on Pay Rs.22740/- plus Additional Allowance of Rs.500/- Per Month and retained at UBL. His pay is fixed in Functional Grade in PB Rs. 9300-34800 +GP-4200 in terms of Rule 1313(FR-22) (I)(a)(1)(R-II). The above promotion is subject to the following conditions:

1. The promotion will take effect from the date the employee shoulder higher responsibility and he is eligible for Additional allowance of Rs.500/- Per month from the date he shoulders higher responsibility on promotion in PB-2-9300-34800 + GP- 4200 as Mail/Express Guard.
2. He should be free from DAR/SPE/Vigilance cases and not undergoing any Penalty debarring them for such promotion, on the date of his promotion.
3. His promotion is subject to disposal of cases pending in Hon'ble High Court /Supreme Court / CAT etc. if any.
4. The date of relief / joining & shouldering higher responsibility should be immediately advised to all concerned.
5. As per RBE no. 98/97, the cases wherever the employees are not relieved even within three months of issue of promotion orders such cases will be put up to DRM. Controlling Officer will be held responsible for not relieving the staff concerned.
6. As per RBE No. 27/2003, protection of pay of senior employee is not possible from the date of promotion of his junior when senior is not allowed to join on promotion in time & it may cause monetary loss to the senior employees if the employee is not relieved in time.

7. If the employee is unwilling for promotion, the same should be obtained in writing by the concerned supervisory official within 15 days from the date of issue of this order and it should be forwarded to this office immediately without fail.
8. The employee may exercise for pay fixation on option as per extant instructions and it should be submitted within one month from the date of issue of these orders.
9. He is promoted against Post No.22 against 'UR' Point.
