Consequent on implementation of cadre Restructuring of Senior Section Engineer(SSE) Categories in Mechanical Department, Hubli Division/ S.W.Railway in terms of instructions contained in Railway Board's letter cited above, the following JE's in PB-2 9300-34800+G.P.4200/- who have been found suitable under restructuring, are promoted to higher grade against cadre restructured posts/Resultant restructured/existing vacancies as indicated below.

The above promotions are ordered subject to the following conditions

01. They should be free from DAR/SPE/VIG. cases and not undergoing any penalty debarring them for such promotion.
02. Their Promotion is subject to disposal of cases if any pending in Hon'ble High Court/ Supreme Court/CAT, etc. as the case may be.
03. It should be notified to the employees that in terms of para 224 (II) (iii) of IREM-I, employees promoted and retained at same stations cannot refuse such promotion since, the same is taken as refusal of work inviting disciplinary action and wherever employees not taking over the higher responsibilities on promotion ordered, the same should be intimated to this office immediately.
04. In terms of CPO/SWR's Letter No SWR/P/R/186 dated 28.02.12, they will be on probation for a period of one year from the actual date of promotion and their confirmation in the post will be subject to successful completion of the probationary period to which promoted .If the appointing authority considers that their work has not been satisfactory during the probation period, they are liable for reversion to the post from which they were promoted or their probation can be extended.
05. The employees (Sl.nos 1 to 12) are eligible to draw higher rate of pay from 01.11.2013 as ordered in above promotions.
06. Employee mentioned at sl.no.13, may exercise option for re-fixation of pay in the promoted grade within one month from the date of promotion in terms of Rule No.1313 (FR-22)(I)(a)(i) from the date of accrual of next increment in terms of instructions contained in RBE No.132/2008. Option once exercised will be final.
07. Sl.08 was transferred on option basis to RCF/Raebareli. If he is already absorbed in RCF/Raebareli Seniority unit, he cannot be considered for promotion in SWR.
08. The date of shouldering higher responsibility should be immediately advised to all concerned without fail..
