

- 1) All the RTI applications received shall be registered with unique case No, and immediately put up to CPIO (Sr.DPO) who shall scrutinize the application and forward the case to the departmental PIO. If the case pertains to only one department, it will be the responsibility of the concerned departmental PIO to prepare and forward the reply timely to CPIO/Sr.DPO for onwards submission to the applicant complying to the RTI Act 2005.
- 2) In case the information is to be collected from more than one department within the Division, the Co-coordinating CPIO (Sr.DPO) shall compelle the reply after collecting the request information from other department for onward submission to the applicant. A copy of the reply should be sent to General Branch for record purpose. The responsibility of maintenance of records will lie in the CPOI & concerned department.
- 3) In case if any application is received by any one of the listed APIOs, whether of the concerned branch or otherwise ,the application shall be immediately sent to CPIO/Sr.DPO for taking further necessary action at his end.
- 4) All the application received in general Branch shall be sent to CPIO i.e SrDPO promptly for further necessary action.
- 5) ADRM/UBL will be the APPELLATE Authority .Appeal will be put up to ADRM/UBL through CPIO/SrDPO/UBL .All necessary close monitoring shall be done at CPIO level to ensure strict compliance to the RTI Act-2005.However, in addition, the moniering at DRM office level will continue as earlier.
