संदर्भ/**Ref**:i) DTC(R) Railway Board's letter No. TCR/1017/2020/2 Part-(1)/3325609 dated 28.06.2021 (**Corrigendum No.21 to Rates Master Circular on Block Rakes/Mini Rakes/Two point Combination etc.2020**).

ii) Rates Master Circular on Block Rakes/Mini Rakes/Two Point Combination etc.2020 and corrigenda thereto.

In terms of Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc.2020 and Corrigenda thereto, Policy of Two Point Combination for covered wagons (for steel traffic only) has been notified.

Matter has been reviewed and Competent Authority has decided to allow Two Point Combination for loading of Bentonite in jumbo bags in open wagons as under:

The loading of Bentonite in the above two point destination terminals shall be subject to levy of 5% supplementary charge of Base Freight rate, and shall be subject to all terms and conditions laid in the above referred Rates Master Circular and Corrigenda thereto.

This shall come into force w.e.f. 01.07.2021 and shall remain in force till further advice.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.
