विषय/**Sub**: Amendment No.9 to FM Circular No.11 of 2016- Policy Circular on Private Sidings.

- संदर्भ/**Ref**: i) Freight Marketing Circular No.11 of 2016 issued vide Board's letter No.99/TC (FM)/26/1/Pt-II dated: 22.08.2016.
ii) FM Circular No.10 of 2017 dated: 25.08.2017 and FM Circular No.13 of 2020 dated: 18.08.2020, issued vide letter No.2016/TC (FM)/18/20.
iii) Freight Marketing circular No. 17 of 2021 issued vide letter No.2020/TC (FM)/18/20/Pt. dated: 11.08.2021.

1. Please refer to Board's letter No. 2016/TC (FM)/18/20 Pt. Dated. 18.08.2020. FM Circular No.13 of 2020- wherein para1(i) of the Private Siding policy, regarding maximum limit of Co-user permission was amended to multiple co-user in Private Sidings with the approval of PCOM, subject to operational feasibility and local constraints.
 - 1.1 The above permission has been reviewed and accordingly para 1 (i) of the private siding policy (FM Circular 11 of 2016) stands amended as under:

Existing Para	Revised Para
Para 1(i): Private siding is only for end users. However, if siding owner desires to permit co-user(s) at his siding, co-user(s) permission can be given (as per definition of co-user given para 2(v) of private siding policy-FMC 11 of 2016 to multi co-users on receipt of written request from the siding owner, with the approval of PCOM, subject to operational feasibility and local constraints.	Para 1(i) : Private siding is only for end users, However, siding owner may permit multiple co-users (as per definition of 'co-user' given in Para 2(v) of private siding policy- FMC 11 of 2016) and inform the Zonal Railways at least : 07 working days in advance. Zonal Railway shall take necessary action for inclusion of such co-users in FOIS, within these 07 working days.
