1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operations. Other conditions and procedures remain same.
3. Northern Railway has forwarded proposal with due approval of General Manager to include
**Chandigarh (CDG)-Morinda (NMDA)-Sanehwal (SNL): and
Bathinda BTI)-Sriganganagar (SGNR)** routes in the list of already identified CC+8 routes.
4. Now, sanction of the Competent Authority is hereby accorded to include above referred routes of Northern Railway in the list of already identified CC+8 routes.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 08.09.2021 and shall remain valid till further advice.
8. The issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
