विषय/Sub: Additional free time for cleaning activities of tank wagons in private sidings in case of edible oil when there is change of product.

One of the Zonal Railways has suggested for grant of additional free time for clearing activities (cleaning, mopping, coating and drying) of tank wagons in private siding(s) in case of edible oil when there is change of product.

The matter has been reviewed and it has been decided to permit additional free time for cleaning activities (cleaning, mopping, coating and drying) of tank wagons in private siding(s) in case of edible oil when there is change of product, by way of incorporating following para in Chapter-I of Rates Master Circular/ Demurrage-Wharfage-Waiver/2016 /0.

"2.8: Additional free time for cleaning activities (cleaning, mopping, coating and drying) of tank wagons in private siding (s) in case of edible oil when there is change of product.

- Additional free time of 4 (four) hours per rake will be permitted for cleaning activities (cleaning, mopping, coating and drying) of tank wagons in private siding(s) in case of edible oil when there is change of product.
- At the time of placing indent, the customer will clearly mention the name of exact product e.g. crude sun flower oil, crude degummed soya bean oil etc. in e-RD module as well as in forwarding note, and not in general terms e.g. edible oil. Documentar5r proof of material like bill of entry will be uploaded in the system and the same will also be enclosed with forwarding note.
- In respect of talk wagon rake, FOIS should flag the last unloaded product old when a rake is supplied for loading from RMS to TMS against indent of different product, the system should automatically allow additional free time as mentioned above.
- Demurrage will be worked after allowing additional free time for cleaning activities and permissible free time for loading.
- The Debit/ Credit scheme of Demurrage will continue to be applicable as per extant guidelines".

These guidelines will be effective for a period of six months w.e.f. 01.10.2021 and rill 31.03.2022.

Zonal Railways will carry out a study to assess the actual time required for cleaning activities of talk wagons and report along with recommendation may be furnished by 31.12.2027, for review by Board.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
