PUBLIC NOTICE

Divisional Railway Manager(Commercial), South Western Railway, Bengaluru Division invites application from educated unemployed persons residing in and around at the below mentioned "Train Halt" Station for issue of Unreserved Tickets on "COMMISSION BASIS" for a period of five years or till up gradation of the station, whichever is earlier.

1. Date of Submission of Application:

Application should be submitted in a cover clearly written as "Application for appointment as halt agent at _____ Train Halt" (Write the halt name for which you are applying) separately. Application filled up in all respects along with requisite enclosures should be dropped in the box kept at the office of the Senior Divisional Commercial Manager, South Western Railway, Bangalore Division, Bangalore - 560 023.

Late/delayed applications received will not be considered.

2. Eligibility Criteria:

- The applicant should have completed 18 yrs. of age,
- Should be a permanent resident of the place where the halt station is located i.e. the residence should be located within the same district.
- Should have passed 10th Standard with a working knowledge of English,
- Should produce a medical certificate showing that he/she is fit for the active service and free from any communicable diseases.
- Should produce a valid Police Verification Certificate from local police authorities of the area where the applicant is residing.
- Should submit application in the Proforma furnished below duly enclosing attested photocopies of certificates.
- All relevant documents in support of their claim should be enclosed along with the application.

3. Nature of Work & Deposits:

The selected applicant is required to issue tickets to the passengers at Halt Station after obtaining the same in advance from the Station Master concerned of the depot station where the tickets are stocked on payment of the value in advance. The Halt agent shall also take care of the cleanliness of the station.

As per terms and conditions of contract for working of train halt, the selected applicant is also required to deposit a sum of Rs.3,000/- Security Deposit for fulfilment of the contract and towards the Railway materials supplied for the use at the train halt. The selected applicant is further required to execute an agreement with the administration on a requisite stamped paper.

4. Period of Contract:

The initial period of contract shall be five years. After, the expiry of the initial contract period of 5 years, the existing Halt contractor shall be given an extension for 5 years (maximum contract period should not exceed 5 + 5 = 10 yrs). The extension shall be in spell of 2 and half years at a time subject to the halt contractor's working being satisfactory and Railway dues paid in time.

Those halt contractors who also maintain the infrastructure of the station at their own cost including provision of water, electricity etc. shall be given another extension of five years i.e. total period of contract may be 10+5=15 years.

5. Commission Payable:

Commission payable to the selected applicant (halt contractors) will be as under:

6. Appointment of Heirs and Successors of Deceased Halt Contractors:

In the event of death of the halt contractor appointment of heirs and successors of deceased halt contractors, may be considered along-with other applicants and preference will be given to the heirs, all other things being equal. Further, it is clarified that if eligible heir and successor of the deceased halt contractor apply, draw of lots may not be required and preference may be given to him/her. However, after the expiry of the contract period, fresh applicants should be called for and selection will be by draw of lots. Draw of lots will, therefore, be carried out only when there is no legal heir.
