

In terms of Ministry of Railway's Order No. no. ERB-I/2012/23/49 dated 09.11.12, and communication no. 2012/E(LR)III/LR/Misc/5(SB)-Pt. dated 08.03.13, vide which Railway Board has advised that "instructions in compliance with courts orders dated 03.03.2010 in WP (C) No. 26/2008 and order dated 30.01.2012 in LPA no 550.2010 of Hon'ble High Court of Delhi which has been upheld by the Hon'ble Supreme Court of India in their order dated 22.01.13 in Special Leave to Appeal (Civil) No. 23523/2012, will follow separately", the Secret Ballot Election Committee was entrusted with the task to frame modalities for election and supervise and conduct the same.

3. The Registered Railway Trade Unions which are interested in participating in the Secret Ballot Elections and which fulfil the eligibility criteria mentioned in Para 1 of the Final Modalities may apply to the Returning Officer of the concerned Railway as per the Nomination form uploaded on the above site address. The Nomination Form should be accompanied by all the necessary documents mentioned in Para- 12.2 of the modalities, in the absence of which the application will not be considered for Union's participation in the Secret Ballot.
