

As you are aware, the process of secret ballot for recognition of unions has already commenced. Code of conduct of elections issued during last elections clearly indicate that pasting of posters on stations, rolling stock buildings, defacing office buildings, colonies etc. is not allowed.

In addition to the above, you may be aware of the provisions of the Rules prohibiting pasting of posters and defacing of railway property etc notified by Railway Board vide Letter No.2010/TG-IV/16/SAN/14/Fine, dated 14.12.2012.

It is requested that members of your union and office bearers may be advised to follow the provisions regarding pasting of posters and defacing of Railway property scrupulously. They may be advised not to indulge in defacing the Railway buildings, structures, colonies etc. and it is also requested that if any area is defaced, then repainting may be done of defaced places, so as to restore it to the original condition.



Sub: **Secret Ballot Elections for the purpose of recognition of Unions.**

The committee constituted by the Railway Board to decide the modalities for conducting of secret ballot elections for recognition of unions/federations has uploaded the draft modalities on the website of the Railway Board on 11.03.2013. The Chairman of the Secret Ballot Election Committee (SBEC) has written to the General Manager regarding collection of Railway dues from the unions on account of rent, electricity, telephone, water charges etc.

As per the clause 1(g) of the draft modalities, the unions shall be eligible to contest the elections only if they enclose a 'No Due Certificate' for having paid all the charges on account of office rent, electricity, telephone, water etc. till 31.12.2012.

It is requested to take necessary action in this regard, so that bills are correctly raised, if not already done and the amount realized from the concerned unions. Necessary action may also be taken to issue 'No due Certificate' to the unions in time so as to enable to them file the nominations in time.



This NOC should cover the period ending 31.12.2012. A separate NOC needs to be submitted for each division covering all facilities in its jurisdiction.




