In connection with the above, notification was issued to all concerned vide reference (1) above calling for applications from Track Maintainers/Gr.IV with Service condition of 20 years in GP Rs.1800 and 50 to 57 years of age as on 01.07.2015 under LARSGESS for July to December 2015 Cycle. The last date to receive application was 31.07.2015.

Railway Board vide letter No.E(P&A) I-2015/FE-4/3 dated 10.09.2015 (RBE No.101/2015) has issued clarification as under.

**"Further to Railway Board letter No. E(P&A) I-2010/RT-2 dated 28.06.11 (RBE No.99/2011) & 15.07.11 (RBE No.107/11) it is clarified that, Trackman/Gangman in GP Rs.1900/- are also eligible for the scheme. The terms and conditions of GP Rs.1800/- shall also be applicable for the GP Rs.1900/- mutatis mutandis so far as the Trackman/Gangman are concerned."**

In view of this clarification, eligible Trackman/Gangman (Redesignated as Trackmaintainer/Gr.III) of Civil Engineering Department in GP Rs.1900/- may submit applications in the prescribed form (Annexure A & B) duly certified and forwarded by the respective supervisory official to Assistant Personnel Officer/Engineering Divisional Office, S.W.Railway, Mysuru.

**All other eligibility terms and conditions stipulated in the notifications cited above holds good.**



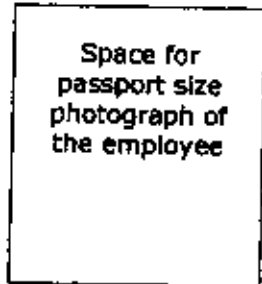
