Applications are called from the staff working against Safety category post in the
following Departments who fulfill the criteria as given below.

Sl.No	Department	Categories
1.	Operating	Pointsman, Gateman, Traffic Porters, Shuntman, Liverman & Trolleyman.
2.	Civil Engineering	Gateman, Trolleyman, Keyman, Gangman/ Trackmaintainer in GP Rs.1800 and GP Rs.1900.
3.	Mechanical & Electrical	Khalasi/Khalasi Helpers redesignated as Helper Gr.II & Gr.I assisting Loco Fitters/C&W Fitters/Fitters in Diesel Sheds and Train Lighting, A.C.Fitters, Trolleyman, Crane Jamadar & Crane Khalasi in GP1800 and Loco Pilots (excluding shunters).
4.	S&T	Khalasi/Khalasi Helpers redesignated as Helper Gr.II & Gr.I attached to ESM/TCM/WTM and Trolleyman.(GP Rs.1800)

In addition to the above, the following categories of staff in GP 1800 are also eligible to
apply for Voluntary Retirement under LARSGESS in terms of Railway Board letter
no.E(P&A)II-2010/RT-2(RBE No.31/2014) dated:24.03.2014

- Electrical Power Staff working on track.
- Track Machine Staff working on track.
- Bridge Staff working on track.
- PWI Khalasi working on track.

Employees belonging to the above safety categories who fulfill the following conditions are
eligible to seek retirement under this scheme:

- Loco Pilots (excluding Shunters) and other eligible safety staff should have put in
minimum 33 years of qualifying service in the category and should be in the age group
of **55 to 57** years, as on **01.01.2016**.
- Employees in Grade pay of Rs.1800/- and Trackman/Gangman in Grade Pay Rs.1900/-
should have put in minimum 20 years of qualifying service in the safety category and
should be in the age group of **50 to 57** years, as on **01.01.2016**.
- In terms of Railway Board's letter No.E(P&A)I-2013/fe-2/3 dated:01.12.2014 (RBE
No.131/2014), for determining the eligibility of the employee in respect of the
prescribed qualifying service of 33/20 years under LARSGESS, an employee is required
to render total qualifying service of 33/20 years, out of which the employee should have
rendered at least the last **ten** years in the concerned safety category post.

The eligibility of the wards for appointment in safety category post with Grade pay
Rs.1800/- under LARSGESS will be as under:

- Educational qualification: X Pass (SSLC) or ITI or equivalent.
- Eligible staff whose wards possess the qualification of "8th Standard Pass" also may
apply which will be considered in exceptional cases. The service conditions and the
age of employee as well as ward seeking appointment will be reckoned as on
01.01.2016.

Such of the wards who do not possess 10th pass or ITI on appointment will be given -1S pay band without Grade Pay on appointment. The period spent in -1S pay band will not be counted as service for any purpose as their regular service will start only after they are placed in the pay band PB-1 of Rs.5200-20200-1800 GP on their acquiring the minimum educational qualification of "S.S.L.C. Pass, I.T.I or equivalent" within five years from the date of engagement/appointment in terms of RBE No.102/2012.

- c. Age of the ward to be appointed is to be within: 18 to 32 years (relaxable by +5 for SC/ST and +3 for OBC).

For determining the eligibility for seeking retirement under this scheme, the Grade Pay corresponding to the post against which the employee is working on regular basis will be taken into account. Employees in the above mentioned Grade pay will continue to be eligible even after getting financial upgradation in Grade Pay higher than Rs.1900/- and Rs.1800/- under MACPS respectively.

The cut off date for reckoning the eligibility will be 01.01.2016 for all purposes, viz., the age of the employee seeking retirement, his qualifying service, age and educational qualification of the ward seeking appointment etc.

Appointment will be done in the lowest recruitment grade in GP 1800 in the respective department where the employee is working in all cases except loco pilots where appointment will be as ALP in 1900 GP. In cases of non-matriculation the pay will be fixed in -1S scale without GP.

The time schedules as advised by Rly.Bd. for processing the applications have already been advised vide this office letter of even No. dated 06.06.2011. However the same is reiterated herewith:

- (i) **Cut off date for reckoning the eligibility of the employee and his ward : 01.01.2016**
(ii) **Last date for receiving the applications : 31.01.2016**

No advance applications will be entertained.

The Supervisory official Concerned shall forward the application duly verified in all respects to this office along with the certified copy of family Composition furnished in the Pass account book, duly signed by the employee and the supervisory official.


Applications received without the signature of the Sup.Official and family composition will be rejected. The photos of both the employee as well as the ward seeking appointment have to be attested by the supervisory official.

All Branch Officers and Supervisory Officials are hereby advised to give wide publicity of the Notification amongst the staff working under their control. The application of staff, in the proforma enclosed herewith, should be forwarded duly verifying the service particulars furnished by the employees, to reach this office on or before **31.01.2016** certain, repeat **31.01.2016**. Applications received beyond 31.01.2016 will not be considered under any circumstances and summarily rejected.

Note: The term 'WARD' will cover only Son and Daughter of the Employee.
