In response to this Office notification of even Number dated 20.04.2017 & 09.05.2017, the list of staff who are eligible to attend the above selection are mentioned in the Annexure 'A'. The staff who are not eligible to attend the above selection are mentioned at Annexure 'B'.

If any of the employees who are found eligible is/are unwilling to appear for the selection, the same should be advised to this office on or before 30.06.2017.

Staff who are eligible to attend the above Selection are mentioned in the Annexure 'A' may be alerted to be in readiness to attend the written examination to be held shortly. The eligible employees may treat this as alert notice to appear in the written examination. The date and venue of the exam will be advised.

The supervisory officials shall relieve the above employees listed in Annexure - 'A' in time to attend the exam with proper relief letter. Instructions to be followed at the time of attending the written exam are stipulated as under:-

That they have to produce identity card issued by the administration to be allowed to appear for the written examination. If they have not been issued identity card, the relieving letter should contain a photograph of the employee attested by the supervisory official.

To use either black or blue colour pen only for writing the examination. No other colour pens marking are to be found in any part of the answer book.

That they will not be allowed to carry mobile or any other electronic device into the examination hall.

No blank page or space should be left in between in the answer book. Unused space should be crossed across the page with pen.

While answering objective type questions, correction of any type i.e. cutting, overwriting, erasing, scoring off ticked answer in multiple choices and ticking another answer, modifying the answer in anyway will not be permitted.

They are permitted inside the examination hall only upto 10 minutes after the commencement of exam. The candidates will not be allowed to leave the examination until the completion of exam.

If they answer the questions in excess of the required number, the same will be ignored. However, if such questions stand evaluated, only the marks awarded against the requisite number of answers attempted first will be included in the tabulation on the top sheet of the answer book and the rest ignored.

The above instructions are only illustrative and not exhaustive. Any other issue related to the conduct of the examination that is existing and not indicated above will also be equally applicable in the conduct of the selection.

The answer books of any candidate who violate these instructions will not be evaluated.

As already advised in the notification No.Y/P.531/VVVVol-17(PQ- 33 1/3) of 20.04.2017, the selection consists of written test and the written examination consists of two parts i.e., Part-A and Part-B as detailed below and the duration of the examination will be three hours for both the part put together.

PART - A: To test the working knowledge in English language.
(50% weightage)

PART - B: To test the General standard of intelligence and proficiency through questions in Arithmetic and General knowledge mainly pertaining to Railway matters and matters pertaining to the work he/she has been acquainted with during his/her Railway Service.
(50% weightage)

It is the responsibility of the supervisory officials to alert the eligible employee for the selection under clear acknowledgement. Acknowledgement has to be forwarded to this office before 30.06.2017.

There will be no Supplementary Examination.
