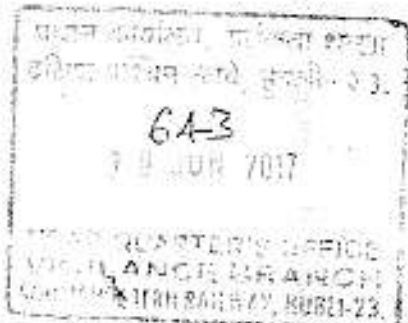

3.0 Eligibility

The posts of Vigilance Inspectors being Ex. Cadre Tenure posts, employees found suitable will be posted as CVI/VIs in the same pay scale held by them. Staff substantively holding any of the posts given in the enclosed list marked as **Annexure-I** in Scale Rs. 9300-34800 + GP 4800/4200 (Pre 7th Pay Commission) for Accounts department and in Scale Rs. 9300-34800 + GP 4200/4600 (Pre 7th Pay Commission) for Elect. / Mechanical / Stores / Engg. / Traffic & Personnel departments only are eligible to apply. For filling post of Vigilance Inspectors in various grades, persons working in one or two grade below the grade for which selection is to be made, may be considered. Employee selected for the post of Vigilance Inspector is eligible to draw a special allowance Rs. 2500/- as per extent rules.

- (i) The candidates must fulfil the following conditions:
- (a) He must be Graduate/Diploma Holder.
 - (b) He must have completed 07 years service.
 - (c) Staff should have sound integrity, should not be figuring in any current Vigilance/SPE/D&AR case and should not have imposed any Major/Minor penalty in any past vigilance/CBI or administrative case at any time.
 - (d) He should be willing to perform arduous duties.
 - (e) He will be posted as CVI at HQ, Baroda House, New Delhi.
 - (f) Staff who have already worked in Vigilance Branch in any Zonal Railway as Vigilance Inspector are not eligible.
 - (g) Vigilance Inspector who are working presently and got higher Grade Pay (Pre-7th Pay Commission) in parent deptt. can apply for the post of CVI.
- (ii) Employee who are Computer trained and have familiarity with WINDOWS, Programming skills and knowledge of hardware, are desirable.

4. Bio-Data cum application form:-

Format for application is given in **Annexure-II**. Applicant must indicate the category of post for which he/she is applying otherwise his/her application is liable to be rejected.

5. Forwarding of Applications:-

8.0 Undertaking by CVIs/VIs


