

Staff on sick/leave may be notified accordingly.

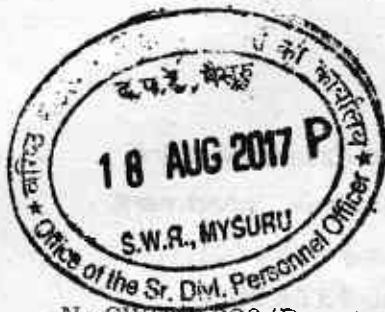
