I. Terms and conditions:

1. For the post of CVI, Volunteers should be working in PB-2 Rs.9300-34800 GP Rs.4600 on regular basis (not under MACP),
2. If the Volunteers are working in Level 6 Pay Matrix, 7th CPC(PB-2 Rs.9300-34800 GP Rs.4200 of VIth CPC), they should have put in minimum two years of regular service in the grade.
3. The volunteers should have put in a total of minimum five years service in Railways as on the date of notification.
4. They should not have served as Vigilance Inspector/Investigating Inspector earlier for a tenure in Vigilance branch/Vigilance Directorate.
4. They should have flair for Vigilance work i.e in Vigilance investigations and other associated works.
6. The job requires extensive travelling/physical hardship, irregular duty hours and also some risks. Therefore, volunteers should be willing to work under such condition.
7. Those who have worked as Chief Enquiry Inspectors in Vigilance organization can apply for the post of CVIs only after a cooling off period of two years.
8. The APARS, awards, punishments record during last 3 years will be taken into consideration. The selection is purely on merit.
9. They should be free from DAR/SPE/Vigilance cases and should not have been taken up under DAR as a result of SPE/Vigilance cases during their entire period of service. They should have good record of service with proven integrity.
10. Working knowledge in computers is desirable.
11. They should be working in a Cadre post and not ex. Cadre post.
12. Application of only those who can be spared on their, selection alone, may be forwarded. If may be noted that it will be compulsory to relieve the employee after selection.
13. Vigilance is an ex-cadre organization. Therefore, staff selected for posting in the vigilance department will continue to maintain their lien and seniority in this parent department/Cadre.
14. Volunteers who are applying in response to this notification should note that they are required to join immediately and refusal to join the relevant post will not be agreed to and the same will be viewed seriously.
15. Applications in the proforma enclosed should be complete in all respects duly signed by applicant and respective controlling & cadre officers.

II. Junior Clerk

For the post of Junior Clerk selection will be based on record of service only and terms and conditions mentioned above(i.e. I. 10 to 15) also apply for this selection.

16. Volunteers who fulfill the above conditions may submit their applications as per the proforma enclosed should be complete in all respect duly signed by the applicant to their Supervisory Officials. The concerned supervisory officials will compile and forward the same to the controlling official in one bunch. The concerned controlling officers will compile all the applications thus received along with adverse comments on the basis of any Vigilance advise and forward the same to concerned Sr.DPO's/WPO's/SPO by 30.11.2017. The respective Sr.DPO's/WPO's/Dy.CPO/CN/BNC/Cadre controlling officers should consolidate the applications so received and send to this office in one bunch by 11.12.2017 duly certifying the particulars furnished in the applications and obtain the approval of DRM/CWM/CAO/Head of the Unit to reach to CPO/SWR/UBL on or before 31.12.2017. Applications received in this office after the stipulated date will not be entertained.
17. Staff working in Headquarters may submit their applications as per the proforma enclosed to their Supervisory official/Controlling officers. The concerned Supervisory/controlling officers on receipt of applications should compile and submit in one bunch with the approval of their PHODs/CHODs to their respective Cadre controlling personnel officers of HQrs. The respective cadre controlling personnel officer of HQrs office should consolidate the applications so received and submit in one bunch duly certifying the particulars furnished in the applications to reach to CPO/SWR/UBL on or before 31.12.2017. In case the lien of the applicant is maintained in Divisions/Workshops, the applications should be routed through the respective Division/Workshop.
18. Applications of only those, who can be spared on their, selection alone, may be forwarded
19. Applications not received through proper channel, applications received after target date and applications forwarded without the approval of Competent Authority DRM/CWM/CAO/PHODs/CHODs (as the case may be) will be rejected summarily.
20. Staff on Sick/leave may be notified accordingly.
21. If no volunteers then a 'NIL' statement may to be sent.
22. Wide publicity may be given in all the Units/Divisions & Headquarter level.
