In terms of Railway Board letters cited above volunteers are called from retired employees of Operating Department/Mysuru Division for re-engagement for the posts mentioned below:

The re-engagement is subject to the following conditions:-

- 13.The scheme is valid upto 01.12.2019.
- 14.Only the employees retired from Mysuru Division, South Western Railway are eligible to apply.
- 15.The Re-engagement shall be strictly upto the age of 65 years on or before 01.12.2019 or till the vacancies are filled up by the regularly selected candidates through RRB/RRC/Departmental Selections whichever is earlier.
- 16.The maximum upper age limit for re-engagement is 65 years. No re-engaged employee should continue in service beyond 65 years of age.
- 17.The Administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct is not found satisfactory.
- 18.The employees who have been Removed/Dismissed/Compulsorily retired as a result of Disciplinary actions or in review are NOT ELIGIBLE for re-engagement.
- 19.Employees who have retired under LARSGESS/SRRS schemes are also NOT ELIGIBLE.
- 20.Monthly remuneration of a retired employee being re-engaged be determined by reducing Pension form his/her last pay drawn (i.e. Basic Pay + DA). The re-engaged employees are not entitled any other benefit or facilities except the monthly fixed remuneration as stated above.
- 21.The employee who is re-engaged shall execute an agreement to abide by all the terms & conditions of re-engagement.
22. Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
23. Suitability/Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
24. The duty hours of the re-engaged employee would be prescribed by the competent authority as per the working conditions of the post.

13. Applicants should enclose copy of any of the following documents along with their application.
- Service Certificate.
 - Pensioner Identity Card.
 - Pension Payment Order.
14. Retired Railway employees, who are desirous for the re-engagement for the posts as mentioned above, should appear for the walk in screening with the application in the proforma enclosed along with documents mentioned above. They can also register their request for re-engagement in the Welfare Cell fo Sr.DPO's Office, Mysuru over phone No. 0821-2428630 prior to appearing for walk in screening for re-engagement.
15. The retired POINTSMAN and GUARDS may appear for the walk in screening to be held at Divisional Personnel Department, Mysuru on every alternate Tuesdays starting from 12.06.2018. If Tuesday happens to be holiday, screening is held on next working day.
