Govt moves amendment to Insolvency Bill

Oppn says 'meant to help one industry'

NEW DELHI, DHNS: The government on Monday introduced amendments to a key Insolvency bill in Lok Sabha that seeks to treat home buyers at par with financial creditors in legal rights of insolvent firms. The Opposition however charged that the bill was being brought to help "one industry".

The Insolvency and Bankruptcy Code (Second Amendment) Bill, 2018, was introduced by Finance Minister Piyush Goyal. The bill replaced the ordinance which was approved by the Union Cabinet in May. "The ordinance brought by the government lowers the minimum vote requirement for passing the resolution to 66%, from 75%, in the original act. This is nothing but a fixed match. It is a clear case of crony

capitalisation and loot of public money," BJD MP Bhartruhari Mahtab said.

Goyal termed the allegations baseless and said the law would not adversely impact anyone. He said the government had gone for amendment of the law only after a consensus in Parliament about the same.

The bill also provides for inserting an explanation under

Section 5, clarifying that any amount raised from an allottee under a real estate project shall be deemed to be an amount having a commercial effect of borrowing.

It also allows the withdrawal of a resolution application submitted to the National Company Law Appellate Tribunal (NCLAT) under the Code on an application made by the applicant with the approval of 90% of voting shares of the committee of creditors.

The amendment also proposed relief for small and medium companies and exempted them from various provisions in the dispute resolution process in which barring wilful defaulters, the owners of MSMEs can bid for their own companies in the resolution process. This will help their turnaround to be faster.

GST rate cut on sanitary napkins: Benefits must be passed on to consumers, says Goyal

Anti-profiteering Authority told to keep tab on prices

New Delhi, July 23

The Centre has directed the 'Anti-profiteering Authority' on GST to ensure that prices of sanitary napkins sold in the country come down after the GST rate reduction decision of Saturday. It is now for the Authority to ensure that the GST rate cut benefits are passed on to the consumers.

This was revealed by interim Finance Minister Piyush Goyal on the sidelines of a meeting organised by Confederation of All India Traders (CAIT) in the Capital on Monday.

Meeting demands

Bowing to demands from various quarters, the GST Council on Saturday decided to bring down the GST rate on sanitary napkins

from 12 per cent to zero. Goyal said he has asked the Anti-profiteering Authority to look at the prices after the notification of Saturday's decision and compare it with the prices on July 1 last year (when GST came into effect) and take appropriate action if prices are not lowered.

"They cannot have the cake

and eat it too," Goyal said, in an apparent reference to industry.

Goyal also told reporters that notion, in certain quarters, that prices cannot be brought down due non availability of input tax credit in the new revised regime is "completely misplaced".

"I have today seen reports in various sections of media that

prices of sanitary napkins may not be lowered because input tax credit set off may not be possible if the end product (sanitary napkin) is exempted from GST. This notion is completely misplaced," Goyal said.

According to a PTI report, manufacturers of sanitary napkins have been continuously demanding that tax rates be brought down so that prices can come down, Goyal told reporters.

If they do not reduce the rate now that means they have been profiteering for the last 12 months and the directorate is already seized of the matter, Goyal said.

Under the Goods and Services Tax (GST) law, the Directorate General of Anti-Profiteering Investigates complaints against manufacturers, dealers and traders for not passing on tax rate cut benefits in the form of price reduction to consumers.

चलती ट्रेन में लाखों की लूट

जबलपुर/वार्ता। मध्यप्रदेश के जबलपुर जिले में सोमवार को तड़के एक चलती ट्रेन में एक महिला जज समेत चार महिलाओं से लाखों रुपए की लूट का मामला सामने आया है। चारों आरोपी चाकू की नोक पर लूट को अंजाम देने के बाद ट्रेन की चेन खींच कर फरार हो गए। शासकीय रेलवे पुलिस, जबलपुर थाना प्रभारी वाय मिश्रा ने बताया कि आज तड़के करीब चार बजे इंदौर-जबलपुर ओव्हरनाइट एक्सप्रेस में चार महिलाओं के साथ चार आरोपियों द्वारा लाखों रुपए की लूट का मामला दर्ज किया गया है। लूट की शिकार बनी महिलाओं में रीवा में पदस्थ अतिरिक्त जिला दंडाधिकारी आरती शुक्ला पांडे भी शामिल हैं, जो भोपाल से जबलपुर आ रहीं थीं। उन्होंने बताया कि ट्रेन के नरसिंहपुर से आगे बढ़ने के बाद सेकंड एसी में बदमाशों ने चारों महिलाओं से चाकू की नोक पर लूट को अंजाम दिया। आरोपी करीब 50 हजार रुपए नगद, सात मोबाइल और साढ़े तीन लाख रुपए के सोने के जेवर ले उड़े।
