

4. **Field of Eligibility:-** The list of eligible employees within the constituted field based on provisional integrated seniority published vide this office Ir.No.SWR/P.612/VII/Elect./Integrated Seniority, dtd.06.08.2018 is enclosed as Annexure-'A'. In addition to the Annexure-A, a reserve list of eligible employees is enclosed as Annexure-B will be called for the written examination in the event of drop out of the employees constituting the field i.e. Annexure-A. The list of employees is provisional and will be subject to issue of final integrated seniority list on disposal of representations, if any, received from the employees.
- 5(a) The concerned Controlling/Supervisory official should ensure circulation of the Notification so that it reaches to all the eligible employees working under their control listed in Annexures-'A' & 'B' and acknowledgement should be obtained for receipt of the Notification.
- (b) It is brought to the notice of the employees, it is the responsibility of the individual employee that he/she should exercise his/her willingness or un-willingness in the proforma enclosed as Annexure-'D' to appear the selection. Failure to respond the Notification by the employee within the stipulated period will be treated as unwillingness to take the selection on his/her part. It is also made it clear that merely expressing willingness by the employees will not confer the right to appear the selection rather their eligibility to appear the selection will be subject to Board's instructions issued from time to time. Further correspondence will not be entertained on this aspect.
- (c) Employees listed in Annexure-'A', if any is on leave/training/deputation/sick or working in other units etc., intimation regarding this notification should be sent to his/her official/personal address and acknowledgment obtained, forwarded to this office for record immediately. The responsibility of sending such intimation to his/her official/personal address and obtaining the acknowledgement rests with the Supervisory/Controlling officers.
6. The individual employee listed in Annexures-'A' & 'B' has to exercise his/her willingness or unwillingness to appear for the Selection in writing in the enclosed proforma Annexure-D and submit it to their Supervisory/Controlling official **on or before 30.08.2018 positively.**
7. The concerned Supervisory/Controlling officials, on receipt of willingness/unwillingness in the prescribed proforma Annexure-D should compile the same in one bunch and submit it to the concerned Dy.CPO/Sr.DPO/ SPO/WPO/Cadre Controlling officers so as to reach them **on or before 06.09.2018.**
8. The concerned Dy.CPO/Sr.DPO/SPO/WPO/APO/Cadre Controlling Officers should consolidate all the Annexure-'D' forms received from the Controlling/Supervisory officials and send to this office in one bunch so as to reach this office **on or before 14.09.2018.**
9. It is reiterated that the willingness/unwillingness(Annexure-D) submitted by the employees after the stipulated date should not be entertained and forwarded. In such cases only the copy of acknowledgement for having noted by the concerned employees may be forwarded to this office immediately.
10. The employees also be advised to note that, if it is found that he/she is not fulfilling the eligibility criteria of the selection, his/her candidature will be liable to cancel at any stage of the selection.

11. Pre-Selection coaching:- The Pre-selection coaching to the employees belonging to the SC & ST community will be arranged by PCEE. The detailed schedule of the Pre-selection coaching will be advised by PCEE in due course. In case, employees are unwilling to undergo Pre-selection coaching, a written declaration of unwillingness (unconditional) should be obtained from him/her and sent to PCEE. PCEE in turn will forward such unwillingness in one lot to this office for record after completion of the Pre-selection Coaching, along with the list of employees undergone Pre-selection coaching.
12. Syllabus:- The syllabus for written examination is enclosed as Annexure-'C'. As per extant instructions of the Railway Board, the question paper shall also contain question(s) on Official Language Policy and Rules to the extent of 10% of the total marks allotted for professional abilities, which shall be of optional question.
13. The date, venue of written examination will be advised to the eligible employees in due course.
14. The above promotion against the selection will be subject to final outcome of litigation pending in the Apex Court.

**Syllabus for Gr. 'B' selection for the post of ADEE/AXEE in Electrical Deptt.
against 70% quota**

1. GENERAL & TRANSMISSION OF ENERGY:

Power generation in Diesel Power stations, Power House layout specifications etc., specifications for Generators Transformers, Switch Gear protective equipment etc. Execution and Tests, Gas turbine Generating stations and its advantages and disadvantages.

2. H.T. TRANSFORMER & L.T. DISTRIBUTION:

Lay-out design, construction, operation, projection, HT/LT cable resin insulated, capsuled transformers advantages and disadvantages, MOC, CB, SF6, CB, MCCB, MCBs, ACB.

3. ELECTRICAL MOTORS FOR DRIVING MACHINES, TOOLS PUMPS ETC:

Types of motors rating and temperature rise, types of Central Gear, Protective devices and safety features, different forms of drive design and lay-out of electric pumping schemes automatic control pumping plant, Bore well yields, Failure in pump motors, water supply system in Railways.

4. ELECTRICAL LIGHTING OF BUILDING & YARDS:

Systems of wiring layouts, regulations, governing the electrical equipment of building, contract specifications for electrical works, testing of installation, lighting of yards by point lights, flood lights etc. standards of illuminations for yards, different forms of light fittings suitable for special purposes. Switching scheme of street/PF lighting for energy conservation, lighting transformers.

5. TRAIN LIGHTING & AIR-CONDITIONING:

System train lighting advantages and disadvantages of paralleled bank and single battery system. Design feature of TL alternators and automatic voltage regulations cumulative rectifications, specifications and functioning of main items of TL equipment lead acid and VRLA batteries, their characteristics on charge and discharge electro lights care and maintenance of batteries; Battery charging plants, Design features and operation and maintenance of the air-conditioning equipment on the air-condition coaches, air-conditioning plants, water cooler and refrigerators, Centralized AC plant, Roof mounted AC plant, Electronic thermostat inverter, WRA(AC or DC).

6. LOCOMOTIVE HEAD LIGHTS:

System of lighting in Electrical/Diesel locomotives, Design, features of the different types of Regulator, DC-DC type converter, flasher lights, Xenon type, type automatic switch on/off flasher light and automatic blowing.

7. ELECTRICAL TRACTION:

- a) **Rolling Stock** - Electrical locomotive and AC/DC EMUs. Their schematic and control circuit, details of equipment fitted, their commissioning, maintenance procedures and problems, train operation capabilities of existing electric locos, running repair sheds, trip-shed and practices - Trouble shooting, Staff booking and training safety courses, running staff booking Dynamite breaking regeneration during traking of coaching/powering operation on continuous gradient/ghat section.
- b) **EMU/MEMU** - Typical speed-time curves for electric trains acceleration and braking, simple equations. Train resistance & gravitational effects, Overhauling of motor coach, train resistance in curved tracks and tunnels general equations, Specific energy consumption, AC, DC, and AC/DC locos, Main features, starting Torque, tractive efforts, adhesion, how adhesion is improved. Bogies and suspension, power transmission from Traction motors to axles, Jacquemin Drive, Quill-drive, WN Coupler, Axle and wheel sets, Veer of wheels, mountings of Traction Motors, Gear case, Lubrication, Axle Boxes, Friction dampers, oil dampers, Air filters gear case oil leakage.

Power control and auxiliary circuit, silicon diodes rectifiers, thyristers, AC and DC auxiliaries, their relative advantages, effect of line voltage on AC auxiliary performance, protective relays, various contacts, batteries and battery charges.
