In terms of Rly.Bd's letters no. E(NG) I-2000/PM 10/2 dated 03.05.16 (RBE.No. 45/2016), & dated 17.02.2017 (RBE.NO.13/2017), 50% of the vacancies of Dresser Gr.III are to be filled by process of selection from amongst all the erstwhile Group D' categories like Hospital Attendants, Orderlies, Dispensary Peons, Stretcher Bearers, Watchmen, Safaiwalas or Sanitary Cleaner etc which are eligible otherwise in terms of Para 182 of IREM (vol.1), who are possessing the educational qualification of matriculation (10th pass) as per the extant procedure contained in Rly.Bd's letter no. PC-V/98/I/11/18(A) dated 10.05.98 (R.B.E.No. 100/98).

2. It is proposed to hold a selection for the post of Dresser Gr.III for 50% of vacancies classified as "Selection", in pay band Rs.5200-20200+1900(GP) Level-2 from amongst the Matriculate erstwhile Group D staff of Medical Department/Mysuru Division. The number of vacancies and the break-up is as follows:-

SC - 00, ST - 01, UR-02 . TOTAL = 03

3. The erstwhile Group D' employees, who are matriculates, are arranged in order of seniority and in the field of eligibility as shown in **ANNEXURE-I**, may be alerted to be in readiness to appear for the above selection.

4. The selection will consist of written test followed by assessment of suitability by a duly constituted committee of Officers. Stand-by list of employees for selection is enclosed as **Annexure-II**. It is advised that these employees will be included in the main list for enabling them to appear for the written examination only in the case of any of the employee in the main list of Annexure-I expressing his/her unwillingness to appear for the selection on or before the cut off date **i.e.16.11.2018**

(i).They should be prepared to work anywhere on Mysore Division of South Western Railway.

5. The selection is on divisional basis and staff who appear, in the event of their being selected, should be prepared to proceed to any station to which they may be posted in Mysore division.

6. Staff required to attend the written examination will not ordinarily be allowed to go on leave except in urgent cases. Those who absent themselves for written examination for the reason beyond their control will only be considered for supplementary written examination.

7. Date of Examination:

The date, venue and time of examination will be intimated separately. However, it is to be advised to the employees listed in Annexure-I and II that they should be in readiness to appear for the examination at a short notice.

8. Supplementary Examination:

A supplementary examination will be held to the employees who could not attend the main examination in the following circumstances with the approval of competent authority-

(i) Administration's failure to relieve the employees in time for examination/ late intimation of the date of test etc.

(ii) Sickness of the candidate or other reason over which the employee has no control. Unavoidable absence will not, however, include absence to attend wedding or similar function or absence over which he/she has control. Sickness should be certified by Railway Medical Officer.

9. Notifying to the staff:


In terms of Railway Board instructions, the Senior Subordinate/Supervisor concerned has to furnish a certificate that the eligible candidates (including stand by list) were duly notified of the test and asked to submit their applications duly giving their willingness and forward the same to Sr.DPO/MYS. It should be the personal responsibility of the Senior Subordinate/Supervisor to complete the formality in this respect. It is further advised that any other communication received in respect of the selection should invariably be intimated to all the eligible employees. In case of non receipt of any communication the same may be obtained from the Personnel department or from the Controlling Officer. Any laxity in this regard will be viewed seriously. The unwillingness, if any, received from the employees is to be forwarded to Sr. DPO/MYS on or before 16.11.2018.

10. Any unwillingness submitted to this office after the due date will not be entertained and they will be reckoned for selection and no additional persons from the Annexure-II will be called for the selection to make good the shortfall.
