
The employees who fulfill the conditions and who are willing may submit their applications with service details in the prescribed proforma enclosed through their controlling authority.

Applications/options are hereby invited from the staff working under your control, on the prescribed proforma attached, which should be sent duly by the branch officers for filling up the one post of Chief Vigilance Inspector/Personnel on deputation basis in Vigilance Organization in North Central Railway, H.Q. Office, Allahabad. The deputation period will be four years, which may be extended for further period of two years only.

As per Railway Board's letter No. 2016/V-1/INSP/1/3 dtd 27.07.2016 (Enclosed) permitted for seeking applications from eligible candidates from across Indian Railways.

Eligibility Criteria:

- 1) Staff working in Ministerial staff working in any department, Personnel Inspectors, Welfare Inspectors, and Chief Law Assistants, in Railway- excluding stenographers and typists - in the scale Pay Matrix Level-7 (equivalent to PB-II, ₹9300-34800, GP- ₹-4600/- of 6th PC) or one scale below, i.e. in scale Pay Matrix Level-6 (equivalent to PB-II, ₹9300-34800, GP- ₹-4200/- of 6th PC, on a regular basis.
- 2) Candidate should have completed at least five (05) years of continuous service, as on the last date for receipt of applications.
- 3) The minimum educational qualification required is five years Apprenticeship from Railway/Diploma/Graduate in any discipline.
- 4) Candidate must have sound integrity, and should not be figuring in any current Vigilance/SPE/DAR case. NO penalty (Major or Minor) should have been imposed in any past vigilance case.
- 5) Staff who have already completed their tenure in the vigilance organization of Zonal Railway/Unit/Railway Board as 'Investigating Inspector (Vigilance)' or 'Vigilance Inspector' shall not be considered.

Procedure for Submission of Application:

- 6) Application should be made in the prescribed pro-forma, and should be forwarded through the proper channel. Applications not received through the proper channel will be summarily rejected. No direct applications will be entertained.
- 7) Application, as per enclosed pro-forma, must be filled and signed by the candidate himself/herself, giving the correct information to the best of his/her knowledge. No alterations/corrections on the application will be entertained. Applicants must note that if any information furnished by him/her is found to be false at any stage, the application/candidature will be liable to be rejected. Submission of false or misleading information by applicant may lead to D&AR action.
- 8) The applications/options, should reach the Office of the General Manager/Vigilance, North Central Railway, Allahabad, latest by 30.11.2018, duly forwarded through proper channel, along with attested photograph. Eligible candidates should be ready to be called for selection within fifteen days from the closing date of the receipt of applications.

Other Conditions:


- 9) The normal establishment rules applicable to regular selection posts are not applicable in the selection of Vigilance Inspectors [as per para 1208.2 of the Indian Railway Vigilance Manual]. Mode of Selection will rest with the vigilance organization. Weightages will be given to Service Record, ACRs,

length of experience, integrity, knowledge of D&AR proceedings and computers, etc.

- 10) Adequate knowledge of D&AR proceedings and computer proficiency is desirable. Preference will be given to candidates having working knowledge of computers.
- 11) Extant instructions of Railway Board regarding 02 year service for promotion shall be applicable.
- 12) The vigilance work is mainly out-door, involving excessive travelling. Candidate should have interest and physical fitness for the same.
- 13) Applicants, once selected, will not be allowed to withdraw their names.
- 14) It may be noted that it will be compulsory to release the employee after selection.
- 15) The posting in the Vigilance organization is on a purely temporary basis and that the Railway Administration has a right to repatriate the person at any time and without assigning any reason, even if he has not completed initial period of tenure or extension, if any, granted thereto.
- 16) Vigilance is an ex-cadre organization. Therefore, staff selected for posting in the Vigilance department will continue to maintain their lien and seniority in their parent cadre.

Sub: Selection of Vigilance Inspectors - permission for seeking applications from other Zonal Railways for the posts of Vigilance Inspectors.

A large number of representations are being received from the Zonal Railways that suitable candidates are not coming forward to work as Vigilance Inspectors. It has also been noticed that many Vigilance Inspectors of Zonal Railways are not performing upto their full potential as they fear being victimized on going back to their parent cadre.

A proposal for granting permission to Zonal Railways for seeking applications for the posts of Vigilance Inspectors from other Zonal Railways has been considered and it has now been decided that Zonal Railways/other units may notify the vacancy circulars for seeking applications from eligible candidates from across Indian Railways not filling the vacancies of Vigilance Inspectors. It may be specified that only those applicants who fulfill the eligibility criteria would be considered and that, on completion of their tenure would be repatriated to their parent cadres on the Railway where they hold lien. Selection of outside candidates as Vigilance Inspectors on another Railway will be strictly for the period of their tenure and will not entitle them to any rights to further postings/promotions or change of lien to the Railway/Unit where they are selected as Vigilance Inspectors.

This issues with the approval of the Competent Authority. This also disposes off North Central Railway's letter no. GM/Vig/NCR/VI/CVI/Part-IV-C dated 25th April, 2016, addressed to Adviser/Vigilance, Railway Board.
