Further to this office notification cited, volunteers are also called for from regular Trackmaintainer Grade III in Level 02 (Pay band Rs.5200-20200-1900GP), Civil Engineering Department, MYS Division along with the already notified Category of Trackmaintainer Grade IV in Level 01(Pay band Rs.5200-20200-1800GP) in the prescribed proforma, to fill up 07 posts of Technician Grade III (Welder) in level 02 subject to the following conditions.

- Trackmaintainer Grade III should possess the knowledge of welding
- Volunteers should have successfully completed the probationary period
- Trackmaintainer Grade III on their promotion should be ready to work over MYS Division as Tech-III(Welder)
- Trackmaintainer Grade III promoted/posted as Tech III(Welder) will not be repatriated to the Trackmaintainer cadre.
- Trackmaintainer III promoted as Technician(Welder) III should progress in the cadre of welder only since the post of Technician III(Welder) has been treated as Cadre post.

All other instructions notified in the letter No.Y/P.536/I/Welder & Grinder/Vol II of 16.11.2018 remain unaltered.

Consequent on the insertion of clause of the eligibility to Trackmaintainers Grade III to apply for the post of Technician III(Welder) in Level 02, the last date for receipt of application at the Unit level for the post of Technician III(Welder) has been extended up to 18.12.2018.
