Sub : Filling up of vacancies of SMs in Level-6 under 15% LDCE Quota –
Operating Department – SBC Division.

It is proposed to conduct a selection to fill up 31 posts (SC-06,ST-03,UR-22) of Station Master in Level-6 under Limited Departmental Competitive Examination quota.

In terms of RBE No. 22/2018, the volunteers hereby called for, from staff who fulfill the conditions mentioned hereunder and they may submit their applications in the proforma enclosed herewith as Annexure 'A'.

Eligibility:

1. Staff of Operating and Commercial Department who are working in Level-1 to Level-5 and Level -1 staff who have rendered a minimum of 5 years regular service as on the date of notification.
2. They should be below 45 years of age as on 24.01.2019, the upper age limit is relaxed for 5years i.e, upto 50 years in case of SC/ST employees.
3. They should possess the qualification of Graduation.
4. Group 'C' staff should have put in a minimum of 2 years of service in the relevant grade at the time of actual promotion.
5. They should be fit in A2 Medical category.


In terms of RBE No. 196/2018, question papers will be 100% Objective Type, Syllabus, mode of exam etc., will be notified separately.

The selected candidates have to undergo the prescribed training, before being promoted as Station Master.

It is requested that wide publicity may be given to the above notification and all the applications handed over to TI/Hqrs/SBC on or before 25.02.2019 and applications in the prescribed proforma, received from the eligible volunteers and TI.Hqrs/SBC may be forwarded to reach this office on or before 26.02.2019 in one branch.

Applications received after 25.02.2019 will not be entertained.
