

The approval of the Competent Authority is here by communicated for the Inter Railway Request Transfer of Shri.Sanjeev Kumar (PF.No.04671181) Sr.ALP/SBC of Bangalore Dn/S.W.Rly in Level-04 on Reversion as ALP in recruitment grade on bottom seniority in Level-02 to Lucknow Dn/ Northern Railway.

The above transfer is ordered subject to the following terms and conditions:-

1. He will rank junior most to all permanent/temporary/Officiating employees in Level-02 of Pay Matrix on the date he joins the new seniority unit in Lucknow Dn/Northern Railway.
2. He should be free from DAR/SPE/Vigilance cases as on the date of his relief.
3. No dues should be pending against him on the date of his relief.
4. He should not seek re-transfer to his parent Division/Unit/Railway at a later date.
5. He is not eligible for CTG, Joining Time, Pass, DA, TA etc., on transfer account as his transfer is ordered on his own request.
6. He should vacate Railway quarters if in occupation or should seek retention as per extant rules in force and also hand over all the railway property, if any in his possession to his supervisor before being relieved.
7. His seniority will be governed by extent rules as applicable to own request transfer.
8. While relieving the staff concerned from the unit, the following formalities may also be complied in terms of Railway Board's letter No. E [NG] 1-2001/TR/16 dt. 21-11-2001 [RBE No. 229/2001].
9. The release Memorandum should have photograph of the employee pasted on it duly attested in the manner that signature of the releasing officer and the rubber stamp below that appear partially on the photograph and partially outside the photograph.
10. The sparing memo should have signature of the transferred employee and his thumb impression, both of which should be duly attested by the officer signing the release memorandum/order with the officer's name and designation appearing below the signature.
11. The date of relief/joining should be intimated to this office and all concerned without fail.
12. His IRRT on out of turn basis has the approval of competent authority as per RBE No.139/2018.
13. He may relive to this office for further relief, as he should be relieved immediately.
This is for strict compliance.
14. His IRRT to LKO Dn/Northern Railway on reversion as ALP will be subject to acceptance of unconditional reversion as ALP in level-02.
