Sub: Implementation of Modified Assured Career Progression
Scheme (MACPS) in favour of Controllers of Operating
Department of SBC Division.

In terms of Railway Board's letters cited above, the following Employees of Operating Department who have fulfilled the stipulated conditions for being considered for grant of benefits under modified Assured Career Progression Scheme (MACPS) have been found suitable by the Screening Committee for grant of Financial upgradation to the next higher Grade Pay.

Grant of benefits under MACPS as mentioned above is subject to the following terms and conditions:

1. They are no DAR/SPE/Vig.cases pending/contemplated against them and they are not undergoing any punishments which debar them from grant of MACP.
2. The Financial upgradation will take effect from the date noted against them.
3. The MACPS contemplates merely a placement on personal basis in the immediate higher grade pay/grant of financial benefits only and shall not amount to actual/functional promotion of the employees concerned.
4. There shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.
5. The financial upgradation under MACP Scheme shall be purely personal to the employees concerned and shall have no relevance to his/her seniority position i.e this will not confer on him/her any seniority benefits.
6. Option under Rule under Rule, RBE No.79/2017(PC-VII/2016/I/6/2 dated:31.07.2017.may be exercised within a period of one month from the date of issue of this Office Order to get his pay fixed in higher grade pay either from the date of his up-gradation or from the date of their next increment viz.,
7. The Financial benefits allowed under MACP scheme shall be final and no fixation benefits shall occur at the time of regular promotion.

The above grant of benefits under MACP has the approval of the competent authority.
