

**The above promotions are ordered subject to the following conditions:-**

1. He is allowed to exercise option for fixation of pay under Rule 1313(FR 22) (I) (a) (i) of R-II in the promotion Pay Band within one month from the date of issue of this Order. If no option is exercised his pay already fixed will hold good.
