The employees listed in the annexure -A, who have been alerted for the above vide this office letter dated 21.01.2019 may please be directed to attend the written test fixed to be held on 11.04.2019 (Thursday) at 14.30 hrs at Railway Kalyana Mantapa Mysore. The duration of the written examination is 03 hours.

As already advised in the notification. No. Y/P.608/I/Engg/LDCE/Vol.I dated 03-12-2018, the selection for the post of J.E.(P.WAY) consists of written test in two papers i.e. Paper I (General Knowledge, basic Engineering & other railway relevant topics) & Paper II (P.WAY Engineering). The papers for the above selection will be in descriptive in nature as the selection has been initiated prior to issue of RBE No.196/2018 dated 14-12-2018.


Employees who are appearing for the above selection have to follow the following instructions.

1. That they have to produce identity card issued by the administration to be allowed to appear for the written examination. If they have not been issued identity card, the relieving letter should contain a photograph of the employee attested by the supervisory official.
2. To use either black or blue colour pen only for writing the examination. No other colour pens marking are to be found in any part of the answer book.
3. That they will not be allowed to carry mobile or any other electronic device into the examination hall.
4. No blank page or space should be left in between in the answer book. Unused space should be crossed across the page with pen.
5. While answering objective type questions, correction of any type i.e., cutting, overwriting, erasing, scoring off ticked answer in multiple choices and ticking another answer, modifying the answer in any way will not be permitted.
6. They are permitted inside the examination hall only up to 10 minutes after the commencement of exam. The candidates will not be allowed to leave the examination until the completion of exam.

7. If they answer the questions in excess of the required number, the same will be ignored. However, if such questions stand evaluated, only the marks awarded against the requisite number of answers attempted first will be included in the tabulation on the top sheet of the answer book and the rest ignored.
8. The above instructions are only illustrative and not exhaustive. Any other issue related to the conduct of the examination that is existing and not indicated above will also be equally applicable in the conduct of the selection.
9. The answer books of any candidate who violate these instructions will not be evaluated.
10. The employee while appearing for the written test should bring the enclosed format (ANNEXURE-B) duly forwarded by the concerned supervisory official and handover the same on the date of examination without fail
11. **Employees appearing for the written test may answer the questions either in English or Hindi. Answering questions partially in Hindi and partially in English is not permitted**

If any of the employees listed in Annexure is on leave/sick/training/deputation, intimation regarding their eligibility to appear for the selection is to be sent to their personal address and intimation in the regards may be given to this office for record. It is reiterated that the responsibility of sending intimation to their personal address rests solely with the supervisory official concerned. There will not be any supplementary written examination for the above selection


