Applications were called for the post of Staff & Welfare Inspector in Level 06 [PB Rs.9300-34800-4200 (GP)] in Personnel Dept./MYS Divn/SWR against 35% quota from the eligible employees of Mysuru Division & MYSS.

The final list of eligible employees considered for the above selection is enclosed herewith as **Annexure-A. Sl.No. 7, 8, 22 & 23 of Annexure 'A' are made eligible provisionally, subject to verification of original documents.** The concerned employees may please be advised of their eligibility. The eligible employees may be advised to note that if, it is found that they are not fulfilling the eligibility & other criteria required for the selection, at any stage of selection their candidature is liable to be cancelled. The eligible employees may treat this as alert notice to appear in the written examination.

It is the responsibility of the controlling officers/ supervisory officials to intimate the date & time of written examination to all the eligible employees working under their control.


In case, any of the employees who are under leave/sick/working elsewhere/deputation/training etc., they should be advised immediately at the present official/personal address known under clear acknowledgement without fail. The responsibility of sending the intimation rests with the respective Controlling Officers/ supervisory officials.

The Controlling Officers shall ensure that all the eligible employees under their control are relieved in time along with relief letter to attend the examination.

All the eligible candidates are alerted to be in readiness to attend the exam at short notice.

There will be no supplementary written test.

The Supervisory officials should obtain the acknowledgement from the employees and the same has to be forwarded to this office on or before 29.03.2019.
