विषय/**Sub:** Duplication of names in Final Voters Lists for SBE-2019.

In terms of para 2 (C) of the Draft Modalities issued for the Secret Ballot Election-2019, the 'Non-Gazetted Railway Servants, who are serving on deputation as on 01.7.2019 shall be eligible to vote in the Office where their lien is being maintained'. The term indicated therein is applicable for such of those staff who are on deputation to RVNL, IRCTC, Other Ministries, etc. This is not meant for those staff whose lien is maintained in one unit of Railways such as UBLS, whereas the staff are actually working in PCME Office, DGM(O), or in RRB. These are not considered as working on deputation for the purpose of SBE-2019.


2) Therefore, such of those staff who are deputed to work in other Offices within Railways, have to exercise their right of voting in the same unit in which they are currently working.

3) According, the following staff of UBLS, whose lien is maintained in UBLS and are working at PCME(O), DGM(O), RRB, have to vote in their present Office, Station of Working (HQrs Office or RRB) and not in UBLS. The list of such staff of UBLS is attached as Annexure-I. The names shown against Sl.No:1 to 16 in Annexure-I may be deleted from the Voters List of UBLS and will be retained in the lists of HQ & SBC Dn. In respect of Shri Adat Rao RV, ChOS/UBLS, the same is to be included in the Voters List of UBLS.

4) Accordingly, the 16 names from S.No.(1) to (16) are be deleted from UBLS Final Voter List & S.No.(17) above is required to be included in UBLS voter list and it will not figure in HQrs list.

5) All Divisions/Units, including Headquarters, will undertake a review and make correction accordingly, duly advising the Units concerned besides informing this Office.
