Sub: Re-distribution of Divisional Jurisdiction over south western  
Railway - exercise of option.

1. In terms of R.B.letter cited under reference No.1 above, the Jurisdiction of Mysuru, Bengaluru and Hubballi Division of South Western Railway has been revised. In conformity with the guidelines, the following are specified:-

1. The section between Mysuru to Yeliyur (30.15 kms from 131.85 to 101.70) is transferred from Bengaluru Division to Mysuru Division and the new Divisional boundary between these two divisions will be at 101.700 km.
2. The section between Tumakuru to Sampige Road (39.80 kms from 70.50 to 110.300) is transferred from Mysuru Division to Hubballi Division and the new Divisional boundary between these two divisions will be at 400.300 Km.
3. The section between South Hubballi to Karajgi (62.70 kms from 463.00 to 400.30) is transferred from Mysuru Division to Hubballi and the new Divisional boundary between these two divisions will be at 400.300 Km.
4. The section between Kotturu to Amaravathi Colony (59.30 kms from 135.00 to 75.70) is transferred from Hubballi Division to Mysuru Division and the new Divisional boundary between these two divisions will be at 75.700 km.

II. As per PCPO/UBL letter No.SWR/P/R/64/Misc/vol I of 27.09.2019, the following decisions have been taken in the context of revision of jurisdiction of three division of S.W.Railway

1. The Sections will be transferred to the new Divisions along with the posts on as is where is basis.
2. Staff will remain in the existing post as it is.
3. Staff shall be given-one month time to exercise options by the respective Divisions and finalise the seniority of staff within a period of 03 months.

In terms of the above directions of HQ/O/UBL letter No. SWR/P/R/64/misc/ vol I of 27.09.2019, options of the employees of all Departments of Mysuru Division ( Except Security Accounts) working in the undermentioned sections of Mysuru Division have been called for in the enclosed proforma. Employees will have the following options.

They may exercise their options to (1) opt for UBL Division (for the employees in the section forming part of UBL Division on revised jurisdiction) and (2) opt for SBC Division (for the employees in the section forming part of SBC division)

or

Opt to remain in MYS division.



**Employees of all Departments of MYS Division in the following sections are eligible to exercise options in the proforma enclosed as Annexure to this letter.**

1. Employees of all Department working between South Hubballi to Karajgi (62.70km from 463.00 to 400.30):- Will have the options either to go to UBL division or to remain in MYS Division.
2. Employees of all Departments working in the section between Tumakur to Sampige Road (39.80 km from 70.50 to 110.300):- Will have the options either to go to SBC division or to remain in MYS Division.


For the employees opting either to remain in MYS Division or opting for UBL Division /SBC Division (as the case may be), the seniority will be determined/assigned as per extant rules. Such of the employees who are working in the above sections who opt to remain in Mysore division, are liable to be transferred from their existing sections/stations, since their existing place of work/sections is going to be part of another Division. Posting of employees who come on option/remain on option to/on MYS Division (under revised jurisdiction) will be decided by the competent authority in relation to the number of sanctioned posts (incl. newly created posts/additional posts, if any) available in the division.

The last date for exercising option is 15.11.2019. Those who do not exercise option within the stipulated time will be deemed to have opted to remain in MYS Division. The option exercised by the employees may be sent in one bunch through the respective Supervisory Officials/ Controlling Officers duly forwarded so as to reach this office on or before 15.11.2019. It will be the personal responsibility of the Supervisory Officials/Controlling Officers to ensure that the employees working under their control exercise the specified options available to them.

Option once exercised will be final.
