It is proposed to conduct a Selection for the post of Ticket Examiner in Level-3 to form a panel of 30 (Thirty) employees (SC- 5, ST- 2, UR- 23) by empanelling Staff of Operating and Commercial Dept. Staff of SBC Division in Level-1 and Level-2 in pay matrix (VII CPC) against 16.2/3 % LDCE quota.

Staff of Operating and Commercial Dept including Catering staff in level-1 and level-2 who fulfil the following conditions are eligible for consideration.


1. The employees of Operating and Commercial Department in Level-01 and Level-02 in Pay matrix (VII-CPC) are eligible
2. They should possess educational qualification of 10+2/ PUC/Intermediate or equivalent to 10+2 with not less than 50% marks in the aggregate; however the existing staff as on 17.12.2014 with the pre revised qualification of Matriculation/SSLC/10<sup>th</sup> pass with not less than 50% marks in the aggregate are eligible. 50% marks is not insisted upon in case of SC/ST employees.
3. They should have put in a minimum of 2 (two) years of regular service in the concerned Seniority unit as on date of issue of this notification.
4. Substitutes and Casual Labourers are not eligible.
5. They must be fit in medical classification Bee-Two.
6. They should have working knowledge of English.
7. The selection consists of a Computer Based Test (CBT) of 02.00 hrs duration. CBT consisting of a) General English, b) Simple Arithmetic and c) General Knowledge. At least 10 percent of the total marks prescribed for the CBT will be on official language policy and rules which will be optional.

The Selection will be entirely competitive and based on merit. It will be commensurate with the qualification of Matriculation & the panel will be formed strictly on the basis of merit.

This may please be given wide publicity among all eligible staff. Willing staff may submit their applications in the Proforma enclosed through their supervisory officials concerned, so as to reach this office on or before **17.01.2020**
