Sub: Selection from erstwhile Gr. 'D' to Gr. 'C' as Ticket Examiner in Level-03
(VII CPC) against 33.1/3% quota from Staff of Operating & Commercial
Department/SBC Divn.

It is proposed to conduct a selection for the post of Ticket Examiner in Level-3 (VII CPC) to form a panel of 61 employees (SC-09, ST-05, UR-47) by empanelling Staff of Operating and Commercial Dept. including Catering Staff of SBC Division in Level 01 and Level 02 of Pay matrix in VII CPC against 33.1/3 % promotional quota who satisfy the terms and conditions indicated hereunder:

- 1 The employees of Operating and Commercial Department in Level-01 and Level-02 in Pay matrix (VII-CPC) are eligible
- 2 The employees in Level-1 should have put in a minimum of 2(two) years of continuous service as on the date of issue of this notification on successful completion of probation period, irrespective of the fact whether such staff belongs to GEN/OBC/SC/ST as per the Railway Board letter No. E(NG)I-2015/CFP/8. Dated: 21.04.2017.
- 3 Substitutes and Casual Labourers are not eligible.
- 4 They must be fit in medical classification Bee-Two.
- 5 They should have working knowledge of English.
- 6 The selection consists of a Computer Based Test (CBT) of 02.00 hrs duration. CBT consisting of 2 Parts, Part 'A' to assess the working knowledge in the English language and Part 'B' to test the General Standard of Intelligence and Proficiency through question in Arithmetic, General knowledge mainly pertaining to Railway matters related to the work acquainted during their Railway Service. At least 10 percent of the total marks prescribed for the CBT will be on official language policy and rules. Which will be optional.

This may please be given wide publicity among all eligible staff. Willing staff may submit their applications in the Proforma enclosed through their supervisory officials concerned so as to reach this office on or before 16.01.2020


All the applications received should be forwarded to this office in one bunch in a cover addressed to Shri. Raju G F, DPO/T&E/SBC.
