The above financial up-gradation under MACP Scheme is subject to following conditions:-

1. The employees should be free from DAR/SPE/Vig. cases & not under going any penalty as on date of eligibility.
 2. Such financial up-gradation to higher grade pay is purely personal to the employees concerned and shall have no relevance to there seniority position etc. & this will not confer seniority benefits in higher grade pay.
 3. There shall be no change in the designation, classification; the nature of the duties performed by the employees i.e. the status of employees will remain unchanged. However, financial & certain other benefits which are linked to the pay drawn by employees such as HBA, allotment of Govt. accommodation shall be permitted.
 4. The MACPS contemplates merely a placement on personnel basis in the immediate Grade pay/Grant of financial benefits only and shall not amount to actual/ functional promotion of the employees concerned.
 5. The employees may exercise option for fixation of pay in terms of instructions under Rule 1313 (FR 22) (l) (a) (i) in terms of Railway Board's letter No. E(P&A)II-81 PP-4 dated 13.11.1981 within one month from the date of this office order. Option once exercised shall be treated as final. In case, the employees exercises option for fixation of pay under MACP Scheme, no further provision for exercising option will be available on regular promotion if it is in the same grade pay as granted under MACP Scheme.
 6. The financial up gradation will take effect from the date noted against the employees.
 7. The financial benefits allowed under MACPS shall be final and no pay fixation benefits shall occur at the time of regular promotion.
 8. Employees who are eligible for option pay fixation may exercise option within one month from the issue of this office order. Pay fixation will follow.
