Sub: Filling up of vacancies of Station Master in Level-6 against  
25% General Selection Quota - Operating Department - SBC Division.

It is proposed to conduct a selection to fill up posts of Station Master in Level-6 under 25% General Selection (PRQ) quota. The number of vacancies for which selection is conducted with breakup of SC/ST/UR is as under:

UR	SC	ST	Total
23	08	03	34

The volunteers hereby called for, from staff who fulfill the conditions mentioned hereunder and they may submit their applications in the proforma enclosed herewith as Annexure 'A'.

**Eligibility and Service Conditions of Staff:**

In terms of RBE 22/2018, Volunteers are called from employees working in the category of Operating Department. They should possess education Qualification of Matriculation.


- Shunting Jamadars, Shunting Masters, Cabinmen gr-I, Switchmen, Sr.Signallers and Sr. Train Clerks in Level-4 and Leverman Gr-I, Pointsman Gr.I, Shutman Gr-I, Cabinman Gr-II and Train Clerks in Level-2 with an Upper age limit of 45 years (50 years in case of SC/ST).**
- Staff in Level -1 (erstwhile 6<sup>th</sup> CPC GP Rs 1800) are allowed to appear with qualification of Matriculation and 5 years of regular service.**
- In terms of Railway Board's Lr. No. E(NG)I/2005/PM1/52, dated: 22.08.2006, the cut-off date for determining the eligibility of the staff should be the date of issue of notification. As such the volunteering employees should fulfil the eligibility criteria as on the date of issue of this notification.

**Mode of Selection:**

The positive act of selection to assess the professional ability of the candidate shall consist of Computer Based Test (CBT). The candidate has to obtain a minimum of 60% marks in professional ability, i.e., in CBT, for being considered for further selection process of Psycho test, perusal of service record and APARs. The post of Station Masters being classifies as "safety Category Post", there is no relaxation in qualifying marks to employees belonging to the category of SC/ST and hence they are also required to secure 60% marks in the written examination.

**Procedure for written examination:**

- As per RBE No 196/2018, the question paper will be 100% Objective Type; All the questions will be of multiple choice only.
- As per RBE No.194/2019 there will be negative marking @ 1/3 marks for a wrong answer for all selection including LDCE where panel is arranged in the order of merit from those qualified.
- As per RBE No. 97/2019, duration of the written test will be 120 minutes.

### Pre- Selection Training:

Staff belonging to the reserved category who are to attend the written examination are required to undergo pre-selection training for a period of three weeks, in terms of RBE No. 71/91. Training must cover the syllabus of the examination to be conducted for selection to safety category posts. Sr.DOM/SBC may please arrange for pre-promotional training for the staff belonging to reserved community. Completion of the training may immediately be advised to this office.

### Syllabus :

The syllabus prescribed for selection to the post of Station Master will be circulated at a later date.

### Date of Examination:

The exact date and venue of written examination will be intimated in due course to the eligible volunteers.

### Supplementary Examination:

No Supplementary examination will be held under any circumstances

### Procedure for drawal of Panel:

In terms of Rly. Bd's letter No. E(No) I -200d/PM 7/4 SLP, dated 19.06.2009, the final panel shall be drawn in the order of merit based on aggregate marks of "Professional ability", " Records of service" & "Psycho test marks", since the zone of consideration is not confined to three times the number of staff to be empanelled. However, a candidate must secure a minimum of 60% marks in the 'Professional ability' and 60% marks in the aggregate for being placed on the panel and final empanelment is subject to the availability of vacancies.

### Notifying to the staff:


The willing and eligible volunteers have to submit their applications in the prescribed proforma enclosed as Annexure-A alongwith self-attested copies of relevant educational qualification certificates and caste certificate in respect of SC/ST employees issued by the competent revenue authorities of the respective state Government(s) duly attested by their controlling supervisors on or before 04.04.2022 who will forward the applications in one bunch to the controlling officer on or before 06.04.2022. The controlling officer has to forward all the applications in one bunch to Sr.DPO/Co-ord/SBC together with DAR/SPE/Vig clearance on or before 08.04.2022. No application should be received after the last date indicated above.

The applications which are received directly/without attested copies of the certificates/incomplete/which do not fulfil the requirement or received after the last date i.e after 04.04.2022 or without forwarding from supervisory official/ Sr.DOM/SBC will not be considered and no correspondence in this matter will be entertained.

If any of the staff working under your control are on deputation or transfer on tentative basis etc., should also be advised regarding the selection and applications are to be called for.

Such of those staff who are under suspension or against whom the departmental proceedings have been initiated or proposed to be initiated for the imposition of major penalty or investigation of serious allegation of corruption etc is in progress, should also be called along with other eligible staff to appear for the Selection. In terms of Railway Board's letter No. P(D&A) 88-RG-8/21 dated 21.09.1988, the facts of the case should however be advised to this office in Name cover addressed to Sr.DPO/Co-ord/SBC in advance.

It is the responsibility of the Supervisory Officials to notify all the eligible staff working under them. Before forwarding supervisory official to ensure that the application is filled in all respects & relevant documents are enclosed.


**Last date for submission of Applications:**
