- 3. <u>Scheme of Selection</u>: The written examination(objective type MCQ), Medical examination, Viva-voce and assessment of record of service under seniority-cum-suitability pattern.
  - a) (i) The written examination will comprise one Paper having 100% Objective type Multiple Choice Questions as paper and pen method.
    - (ii) All Objective type MCQ will carry equal marks.
    - (iii) There shall be negative marking for incorrect answers. One-third of the marks allotted for each question will be deducted for every wrong answer.

- c) Formation of panel for promotion to Gr.B post(s) will be on the basis of 'Seniority-cum-suitability'.
- 4. **Field of Eligibility:** The list of eligible employees within the constituted field based on integrated seniority list of non-ministerial Gr.'C' staff of Civil Engineering Department published vide this office lr.No.SWR/P.612/I/Engg./ Integrated Seniority/Vol.II, dtd.20.04.2022 is enclosed as <u>Annexure-'A'</u>. In addition to the <u>Annexure-A</u>, a reserve list of eligible employees is enclosed as <u>Annexure-'B'</u> will be called for the written examination in the event of drop out of the employees constituting the field i.e. Annexure-A.
- 5(a) The concerned controlling official should ensure that the circulation of this notification should reach all the eligible employees listed in Annexures-'A' & 'B' working under their control and acknowledgement should be obtained for receipt of the Notification.
  - (b) It is brought to the notice of the employees, it is the responsibility of the individual employee that he/she should exercise his/her willingness or unwillingness in the prescribed proforma enclosed as Annexure-'D' to appear the selection. Failure to respond the notification by the employee within the stipulated period will be treated as unwillingness to take the selection on his/her part.
  - (c) It is also made it clear that merely expressing willingness by the employees will not confer the right to appear the selection, rather their eligibility to appear the selection will be subject to Board's instructions issued from time to time.
  - (d) Employees listed in Annexure-'A' & 'B', if any, is on leave/training/deputation/sick or working in other units etc., intimation regarding this notification should be sent to his/her official/personal address and acknowledgment so obtained, forwarded to this office for record immediately. The responsibility of sending such intimation to his/her official/personal address and obtaining the acknowledgement rests with the controlling officials.
- 6. The individual employee listed in Annexures-'A' & 'B' has to exercise his/her willingness/unwillingness to appear the selection in writing in the enclosed prescribed proforma i.e. Annexure-D and submit it to their Controlling official on or before 07.06.2022.

- 11. <u>Pre-selection coaching</u>: Pre-selection coaching to the employees belonging to the SC/ST communities will not be arranged as there is no vacancy of SC/ST.
- 12. <u>Syllabus</u>:- The syllabus for written examination is enclosed as <u>Annexure-'C'</u>. As per extant instructions of the Railway Board, the question paper shall also contain question(s) on Official Language Policy and Rules to the extent of 10% of the total marks allotted to professional abilities, which shall be of optional question.
- 13. The date, venue of written examination(MCQ) paper and pen method will be advised in due course.
- 14. The promotion against the selection will be subject to final outcome of litigation pending in the Apex Court.
- 15. The instructions/procedure contained in Master Circular No.68 regarding Gr.B selection will be followed in addition to the above instructions.
