In terms of Railway Board's letter No.E(NG)II/2010/RC-4/6 dated 27.09.12 & 14.09.17, it has been decided to fill up vacancies in the following categories by re-engagement of retired employees for Gatti Shakthi Unit who have retired from Railway Service under South Western Railway.

Therefore the applications from retired employees who have retired from Railway Service under South Western Railway can apply for re-engagement in terms of the conditions mentioned below:

- 1) The scheme is valid upto till further orders.
- 2) The staff retired from Railway Service can only apply for the re-engagement.
- 3) All the Railway retired staff who have not attained the age of 64 years 6 months as on the closing date of Notification for re-engagement will be eligible to apply.

- 4) The administration is at liberty to terminate the services of the re-engaged employees even before the re-engagement period in case work/conduct is found unsatisfactory.
- 5) The employees Removed/Dismissed/Compulsory Retired as a result of disciplinary action are in review are not eligible for re-engagement. Further employees retired under SRRS/LARSGESS will not be eligible.
- 6) Monthly remuneration of a retired employee being re-engaged be determined by reducing Pension from his/her last pay drawn.
- 7) The retired employee shall execute an agreement to abide by all the terms and conditions after re-engagement.
- 8) Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
- 9) Suitability/Competency of the applicant shall be adjudged by nominated committee before the re-engagement.
- 10) The duty hours of the re-engaged employees would be as [prescribed by competent authority, as per the working conditions of the category.
- 11) Copy of the following documents should be attached with the application.
 - i) Service Certificate
 - ii) Pension Identity card
 - iii) Pension Payment Order
- 12) The retired employees from Railways who desires for re-engagement, have to submit their application (<https://forms.gle/ZURLa9SPwJLr72Se9>) online. The website link, the details are available in the SWR website <https://swr.indianrailways.gov.in>. **(About us > Divisions > Bangalore Division > Personnel Branch > Notifications)**.
- 13) Last date for submission of application is **on or before 06.12.2022**. Application received after the last date will not be entertained.
