विषय/Sub: Transportation and charging of 'Track Machine' owned by other than Indian Railways

संदर्भ/Ref: 1) DD (Rates)-II/Railway Board's letter No. TCR/1015/2022/ TrackMachine/ 3400166 dated 24.01.2024 (Corrigendum No. 02 to Rates Circular No. 11 of 2023)

2) Board's Rates Circular No. 11 of 2023 and its corrigendum.

Board's clarification have been sought on the subject traffic. Matter has been reviewed in consultation with Track Directorate and Finance Directorate of Ministry of Railways and following is advised:

- No past cases/movement should be reviewed on the basis of Rates Circular No. 11 of 2023.
- For the speed trial of Track Machine, charges shall be levied as under:
 - For Self-propelled and are required to be carried without attachment of engine, shall be charged @ ` 260 per Track Machine per km subject to a minimum of ` 26, 000/- per Track Machine; and
 - For Non self propelled, and are required to be carried with attachment on engine and shall be charged @ ` 550 per Track Machine per km subject to a minimum of ` 50, 000/- per Track Machine.
- If crew and other staff of IR are provided for movement of the machines of private parties then relevant charges may be decided by the personal department in consultation with Associate Finance.

This issues with the concurrence of Finance Directorate of Ministry of Railways.
