Vide Rates Circular and corrigendum thereto referred above, the commodity "Polyhalite (all types)" was assigned Class 130A in Group No. 6 under the Main Commodity Head – "CHEMICAL MANURES" at Page No.11 in Goods Tariff No. 49 Part-I (Vol.II), below existing entry 'NPK FERTILIZER'. This has validity up to 15.02.2024.
2. The matter has been reviewed and the Competent Authority has decided to extend all the provisions of Rates Circular No. 02 of 2022 beyond 15.02.2024 till further advice.
3. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
