2. The same classification was extended in terms of corrigendum no. 01 to Rates Circular No. 03 of 2022, dated 13.02.2023 till 17.02.2024.
3. The matter has been reviewed and the Competent Authority has decided to extend the validity of corrigendum no. 01 to Rates Circular No. 03 of 2022, dated 13.02.2023 beyond 17.02.2024 till further advice.
