
2) IRCA Goods Tariff no. 49, Part I (Vol.II)

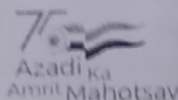
3. These instructions shall come into effect from 10.03.2024 and shall remain in force till further advice.
