

In terms of Corrigendum No.38 of Rates Master Circular under reference (ii), the rate of Stabling Charge in case of all privately owned wagons including wagons owned by container operators is Rs.630/- per wagon per day or part of a day. These guidelines are valid upto 31.03.2024.



The matter has been reviewed and it has been decided to revise the rate of Stabling Charge as Rs.650/- per wagon per day or part of a day in case of all privately owned wagons including wagons owned by container operators, with effect from 01.04.2024 for a period of one year i.e. upto 31.03.2025.

This issues in consultation with Freight Marketing Branch & Traffic Transportation Directorate and with the concurrence of Finance Directorate of Railway Board.
