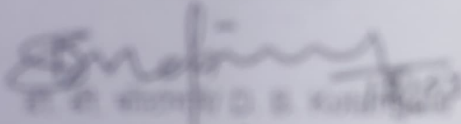

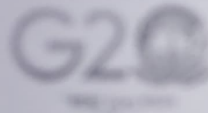
Concurrence No 105 to Rates Master Circular /PCG/CC+8 etc/2020/6

1. Please refer to Annexure II to Rates Master Circular under reference at (i) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain the same.
3. South Eastern Railway has forwarded proposal with due approval of General Manager to include Bankura(BQA)-Sonamukhi(SOMA) route in the list of already identified CC+8 route.
4. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above referred route of South Eastern Railway in the list of already identified CC+8 routes subject to Speed Restriction of 40 kmph.
5. Accordingly, Annexure-II of Rates Master Circular under reference (i) above shall be modified.
6. All other details of the Rates Master Circular & Concurrence thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 12.03.2024 and shall remain valid till further advice.
8. This issue in consultation with Traffic Transportation, Civil Engineering Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
