Referring: i) RD, TCR/Railway Board's letter No. TCR/1978/2019/2/TEFD/23/18166 dated 26.03.2024 (Rates Circular No. 03 of 2024)
ii) Rates Circular No. 07 of 2023 and Corrigenda thereto

1. In terms of Rates Circular under reference and Corrigenda thereto, guidelines were issued for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD). This Scheme is operative up to 31.03.2024.
2. In terms of Corrigendum No. 4 to RC No. 7/2023, automatic freight rebate scheme for automobile traffic loaded in INVS group of stocks, BC/DMR and BC/ADM wagons were issued and the same is also valid up to 31.03.2024.
3. The matter has been reviewed. Detailed guidelines for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD) are enclosed.
4. The revised instructions shall be operative w.e.f 01.04.2024 to 31.03.2025.
5. Zonal Railways are advised to ensure that wide publicity is given to this Rates Circular and also hold meetings with customers at Zonal and Divisional levels.
6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.
