## वाणिज्य परिपत्र (माल) सं 50/2024 COMMERCIAL CIRCULAR (GOODS) No. 50/2024 दर सूचना सं.2024 का 04 RATE ADVICE NO. 04 of 2024

विषय/Sub: Running of freight trains on CC+8 tonne routes

संदर्भ/Ref: i) JDTC (R)/Railway Board's letter No. TCR/1394/2020/4(Part)/3338337 dated 19.04.2024 (Corrigendum No. 106 to Rates Master Circular/PCC/CC+8 etc./2020/0)

ii) Board's letter No. 2018//E&R/1(8)/4 dated 24.04.2018

iii) Rates Master Circular/PCC/CC+8 etc./2020/0 dated 01.05.2020

- 1. Please refer to Annexure III to Rates Master Circular under reference at (iii) above, wherein list of CC+8 routes is prescribed.
- 2. In terms of reference (ii) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
- 3. Northern Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:
  - a. Abohar-Fazilka (ABS-FKA)
  - b. Verka-Dera Baba Nanak (VKA-DBNK)
  - c. Rohtak Panipat (ROK-PNP)
  - d. Narwana-Kurukshetra(NRW-KKDE)
- 4. Sanction of the Competent Authority is hereby accorded to include the above referred routes of Northern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 45 kmph. This limit shall be reviewed by the zonal railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (iii) above shall be modified.
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 7. These instructions shall come into effect from 22.04.2024 and shall remain valid till further advice.

8. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
